**CALL MEETING TO ORDER** – The meeting was called to order at 9:06 PM.

## TREASURER'S REPORT

- Financial Reports At the end of August Current Assets were \$60,644. Net Income for the month was -\$7,624 and Year to Date was -\$3,384.
- Delinquency The Delinquency Report at the end of August shows 49 residents who have not paid dues for 2025 or before. This represents a total of 15.91% of unpaid dues, leaving the delinquent amount at \$22.305. The last late fee will be applied on September 15<sup>th</sup> per the 2025 fee schedule.

- Common Area Projects
  - Obstruction Removal, Monitoring and Management Angela Carter and Angela Garcia have contacted John Nelson. He said he would come out on September 7 to evaluate our situation and provide a quote to Angela Carter who will forward it to Angela Garcia and Chris. Once Chris approves the pricing and signs it, he will turn it over to Angela Garcia to finalize and implement.
  - Wetlands Brush Removal and Management After the August meeting, Angela Garcia contacted
     Ozzy from AG Lawn who indicated the cutback would begin. This has not yet been detected.
  - Trees and Bushes Angela Garcia reported that AG Lawn indicated that the remaining trees would be removed. This has not yet been detected.
  - Landscape Beds at Rockwell Entrances Angela Garcia has inspected the new landscaping installation, and plants were installed per the quote.
- Other Projects
  - Councilman Mark Stonecipher / Water Management On hold.
  - Website Since it is so late in the calendar year, and we are planning to change our website
    format, Angela C will work on a 2025 Annual Report. Angela C and Calvin think that they could
    set up and manage a website rather than hire Angela Drabek to do so. They will focus on this as
    soon as the Neighbors Night Out event finishes on Tuesday. We will need to respond to Angela
    Drabek on this.
  - Section Representative Program Marsha provided Calvin with information she had collected
    on potential Section Representatives. She mentioned that if he could locate the information she
    had provided earlier, that information was sorted by Sections to make contacting individuals

- Violation/Tree Letter Marsha will ask Cathy to forward a copy of the Violation/Tree letter to the Board.
- Neighborhood Night Out Angela C and Calvin reported on the setup for Neighbors' Night out on September 9 from 6 to 8 in the playground area. We have food and snow cone trucks. No food will be over \$10. As long as the food truck brings in \$500, we will not be required to pay a fee. A Bouncy House will also be available next to the playground. Signs have been put up at our 4 entrances and Angela C is going to tie balloons on them on Tuesday. Angela G sent out an email notification on Thursday and has offered to do a follow-up on Monday, if desired. Calvin has contacted the Neighborhood Alliance and planned for possible visits by a Resource Officer, a Firetruck and/or a Waste Management Truck. Angela C is bringing a table and Calvin will bring chairs for the Board. All Board members will have shirts. Calvin will get in touch will Chris to see how we can manage a raffle using the gift card money from AG Landscaping. This has not yet been promoted but will be if we can manage to make it work. A last-minute idea was sidewalk chalk for the kids. Angela C will follow up on this.
